Under suspension of the rules, on motion of Mrs. Parente of Milford, the order was considered forthwith; and it was adopted. Sent to the Senate for concurrence.

Quarterly Report.

The quarterly report of the Division of Employment and Training (under the provisions of Section 68 of Chapter 233 of the Acts of 1983) relative to the condition of the Commonwealth's Unemployment Insurance Trust Fund for the period ending October, 31, 2002, was placed on file.

Papers from the Senate.

The engrossed Bill relative to the concurrent jurisdiction of the Land Court (see House, No. 1989, changed and amended) came from the Senate with an amendment striking out section 23 and inserting in place thereof the following section:

"SECTION 23. This act shall take effect on January 1, 2003.".

Under suspension of Rule 35, on motion of Mrs. Paulsen of Belmont, the amendment (reported by the committee on Bills in the Third Reading to be correctly drawn) was considered forthwith; and it was adopted, in concurrence.

The House Bill relative to state highways in Barnstable County (House, No. 4737) came from the Senate passed to be engrossed, in concurrence, with an amendment striking out section 1 and inserting in place thereof the following section:

"SECTION 1. Notwithstanding section 15C of chapter 40 of the General Laws, chapter 61 of the acts of 1992 or any other general or special law to the contrary, before any reconstruction, realignment, or re-engineering on state highways in Barnstable county, not includ-ing United States highway route 6 except in the town of Eastham, that pass through recognized historic districts that have registered with the department of highways and provided the department with the approximate boundaries of the historic district, whether or not the work pertains to trees or stone walls abutting thereto, the department shall hold a public hearing before any initial design phase. Before holding the hearing, the department shall advertise it in a newspaper of general circulation in the area once in each of 2 successive weeks, the last publication not to be less than 7 days before the date of the hearing, as to time, date, place and purpose. The department shall send special notice to each municipality and the commission of each historic district in which the work is to be performed. The department shall send the notice by certified mail, return receipt requested."

Under suspension of Rule 35, on motion of Mr. Turkington of Falmouth, the amendment (reported by the committee on Bills in the Third Reading to be correctly drawn) was considered forthwith; and it was adopted, in concurrence.

Reports of Committees.

By Mr. Scaccia of Boston, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the petition of Joseph C. Sullivan, Michael W. Morrissey, Robert L. Hedlund and others (by vote of the town) that the town of Braintree be authorized to establish a community preservation account. Under suspension of the rules, on motion of Mrs. Walrath of Stow, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Taxation. Sent to the Senate for concurrence.

By Mr. Mariano of Quincy, for the committee on Insurance, on House, No. 2351, a Bill relative to group marketing plans (House, No. 5375). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Mariano, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Dempsey of Haverhill, for the committee on Public Service, on a recommitted petition, a Bill relative to the effective date of certain civil service laws in the town of Plainville (House, No. 5244) [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Rushing of Boston, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Dempsey of Haverhill, for the committee on Public Service, on a petition, a Bill relative to the health insurance of certain employees of the city of Everett (House, No. 5255, changed in section 1, in line 3 and also in line 4, by striking out the date: "October 1, 2002" and inserting in place thereof, in each instance, the date: "April 15, 2003") [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Peterson of Grafton, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the Senate Bill relative to the recording of certain trust instruments (Senate, No. 866) be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mrs. Parente of Milford, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the Senate Bill relative to distinctive initial plates (Senate, No. 1148) be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Hill of Ipswich, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the House Bill amending certain provisions of the city charter of the City of Lawrence (House, No. 5179) [Local Approval Received] be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Rushing of Boston, the bill was read a second time forthwith; and it was ordered to a third reading.

Engrossed bills

Relative to the civil service status of the positions of director of police services and director of fire services in the town of Arlington (see House, No. 5233, amended); and

Authorizing the town of Norwood to grant 3 additional licenses for the sale of wines and malt beverages to be drunk on the premises (see House, No. 5305);

(Which severally originated in the House);

Severally having been certified by the Clerk to be rightly and truly prepared for final passage, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Mr. Donato of Medford being in the Chair,—

The engrossed Bill providing for the work force reduction of the city of Medford through an early retirement incentive program for certain employees (see House, No. 5351, changed) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Mr. Walsh of Boston having returned to the Chair,—

The engrossed Bill relative to creditable service for town moderators (see House, No. 1469) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was put upon its final passage.

Pending the question on passing the bill to be enacted, Mr. Galvin of Canton moved that Rule 40 be suspended; and the motion prevailed. The same member then moved that the bill be amended by inserting before the enacting clause the following emergency preamble: "Whereas, The deferred operation of this act would tend to defeat its purpose, which is to forthwith grant creditable service for town moderators, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted. Sent to the Senate for concurrence.

Orders of the Day.

Senate bills

Further regulating the use of crossbows in the Commonwealth (Senate, No. 2162); Authorizing the town of Southwick to supply water to certain property located in the city of Westfield (Senate, No. 2370); and

Further regulating the granting of temporary licenses for the sale of wines at certain auctions (Senate, No. 2489);

Severally reported by the committee on Bills in the Third Reading to be correctly drawn, were read a third time; and they were passed to be engrossed, in concurrence.

The House Bill providing for increased organ donations through education and access (House, No. 5246), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill relative to infectious diseases under the public employee retirement law (House, No. 4925) was read a second time; and it was ordered to a third reading.

Recess.

At twenty-six minutes before twelve o'clock noon, the Chair (Mr. Walsh of Boston) declared a recess until half past one o'clock P.M.; and at twenty-one minutes before two o'clock P.M. the House was called to order with the Speaker in the Chair.

Engrossed Bill.

The engrossed Bill relative to open trenches and construction safety (see Senate, No. 2234, amended) (which originated in the Senate), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the Speaker and sent to the Senate.

Valedictory Addresses.

The following members and former members, who were not returning for the 2003-2004 Legislative session, then addressed the House regarding their departure from service in the House of Representatives: Representatives Fitzgerald of Boston; McGee of Lynn; Cresta of Wakefield; Cahill of Beverly; Lewis of Dedham; Rogers of New Bedford; Flavin of Easthampton; Hodgkins of Lee; Caron of Springfield; Slattery of Peabody; Cleven of Chelmsford; Hahn of Westfield; Provost of Sandwich; and Tirone of Amesbury. The Speaker then read a communication from Representative Merrigan of Greenfield, who would not be returning for the 2003-2004 Legislative session, but was unable to be present in the House Chamber for today's sitting.

The Speaker also announced that the following members and former members would not be returning for the 2003-2004 Legislative session: Representatives Barrios of Cambridge; Bunker of Rutland; Donnelly of Boston; Haley of Weymouth; Hart of Boston; Locke of Wellesley; Marini of Hanson; Nagle of Northampton; Santiago of Lawrence; and Tuttle of Barre.
