The installation and operation costs of secondary public safety answering points shall be the responsibility"; and in section 5, as printed, in line 29, inserting after the word "service" the following: "in compliance with provisions required by the Federal Communications Commission. All costs incurred by telephone companies in assisting with the delivery of enhanced 911 service") (on Senate, No. 440), passed to be engrossed by the Senate, was read; and it was referred, under Rule 33B, to the committee on Science and Technology.

A petition (accompanied by bill, Senate, No. 2192) of Therese Murray, Ruth W. Provost, Demetrius J. Atsalis and Matthew C. Patrick (by vote of the town) for legislation to provide for a charter for the town of Sandwich, was referred, in concurrence, to the committee on Local Affairs.
