Engrossed Bills.

Engrossed bills

Authorizing the Division of Capital Asset Management and Maintenance to convey a certain parcel of land to the Taunton Development Corporation (see Senate, No. 1591, changed and amended) (which originated in the Senate);

Relative to the charter of the town of Plymouth (see House, No. 5253);

Exempting the position of chief of police in the town of Carver from the civil service law (see House, No. 5256); and

Authorizing the appointment of Alcino Fernandes as a police officer in the town of Milford (see House, No. 5346);

(Which severally originated in the House);

Severally having been certified by the Clerk to be rightly and truly prepared for final passage, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Orders of the Day.

Senate bills

Relative to the rights of adopted persons under a certain instrument (Senate, No. 825); and Designating the Merrimack Valley Regional Transit Authority Transportation Center in Lawrence as the Senator Patricia McGovern Transportation Center (Senate, No. 2359); Severally reported by the committee on Bills in the Third Reading to be correctly drawn, were read a third time; and they were passed to be engrossed, in concurrence.

The House Bill authorizing the Division of Capital Asset Management and Maintenance to

convey certain land in the town of Ashfield (House, No. 5217), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill clarifying tastings (House, No. 4814) was read a second time. The amendment previously recommended by the committee on Ways and Means,— that the bill be amended by substitution of a bill with the same title (House, No. 5247),— was adopted. The substituted bill then was ordered to a third reading.

The House Bill to establish a paraprofessional incentive program (House, No. 4702) was read a second time.

The amendments previously recommended by the committee on Ways and Means,— that the bill be amended in line 4, by inserting after the word "shall" the words ", subject to appropriation,"; and in line 28, by striking out the word "for" and inserting in place thereof the words "used to defray",— were adopted.

Pending the question on ordering the bill, as amended, to a third reading, Ms. Wolf of Cambridge moved that it be amended in line 12 by inserting after the word "or" the words "paraprofessionals who have worked in public schools for a lesser time".

The amendment was adopted; and the bill (House, No. 4702, amended) was ordered to a third reading.
