Papers from the Senate.

A Bill relative to the division of the Commonwealth into Congressional districts (Senate, No. 2197) (reported from the Senate committee on Ways and Means pursuant to Senate Rule 19), passed to be engrossed by the Senate, was read; and it was referred, on motion of Mr. Peterson

of Grafton, to the committee on Rules.

A Bill making appropriations for the fiscal year 2002 to provide for supplementing certain existing appropriations and for certain other activities and projects (Senate, No. 2198) (reported from the Senate committee on Ways and Means pursuant to Senate Rule 19), passed to be engrossed by the Senate, was read; and it was referred, under Rule 33, to the committee on Ways and Means.

A Bill relative to the debt limit of the town of Holliston (Senate, No. 2155) (on a petition) [Local Approval Received], passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A petition of Robert A. Antonioni and Mary Jane Simmons for legislation to make a technical change to the accelerated transportation development and improvement program for the Commonwealth, came from the Senate referred, under suspension of Joint Rule 12, to the committee on Transportation.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2202) was referred, in concurrence, to the committee on Transportation.

By Mr. Scaccia of Boston, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the following petitions:

Petition (accompanied by bill) of Paul J. Donato relative to authorizing the reinstatement of Frederick Nasson as a member in service of the state retirement system. To the committee on Public Service.

Under suspension of the rules, on motion of Mr. Hargraves of Groton, the reports were considered forthwith. Joint Rule 12 then was suspended, in each instance. Severally sent to the Senate for concurrence.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the Senate Bill relative to the Board of Registration in Veterinary Medicine (Senate, No. 386) be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Peterson of Grafton, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Cabral of New Bedford, for the committee on Human Services and Elderly Affairs, on Senate, No. 673 and House, Nos. 617, 1185, 1595, 1596, 2712 and 3114, an Order relative to authorizing the committee on Human Services and Elderly Affairs to make an investigation and

study of certain Senate and House documents concerning mental health services and services for children and the disabled (House, No. 4799).

By Mr. Mariano of Quincy, for the committee on Insurance, on House, No. 4572, an Order relative to authorizing the committee on Insurance to make an investigation and study of a certain House document concerning insurance premiums paid by employees of the city of Pittsfield (House, No. 4803).

Severally referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.

Subsequently Mr. Scaccia of Boston, for said committees, reported, in each instance, asking to be discharged from further consideration of said orders; and recommending that the same severally be referred to the House committee on Rules.

Under Rule 42, the reports severally were considered forthwith; and they were accepted.

By Mr. Cabral of New Bedford, for the committee on Human Services and Elderly Affairs, on a petition, a Bill relative to Medicaid benefits (House, No. 448, changed in line 4 by striking out the figure: "65" and inserting in place thereof the figure: "72.80").

By the same member, for the same committee, on a petition, a Bill relative to the study of Autism (House, No. 3102, changed in section 2, in lines 4 and 5, by inserting after the word "Representatives" the words ", the joint committee on Human Services and Elderly Affairs and the House and Senate committees on Ways and Means").

By the same member, for the same committee, on House, No. 3344, a Bill relative to mental health care (House, No. 4804).

Severally read; and referred, under Rule 33, to the committee on Ways and Means.
