Reorganization Plan Number 1 of 2003.

A message from His Excellency the Governor submitting (under Article LXXXVII of the Amendments to the Constitution) Reorganization Plan Number 1 of 2003, relative to reforming, restructuring and revitalizing government (House, No. 3901) was filed in the office of the Clerk on Thursday, May 15.

The message was read; and it was referred, under Article LXXXVII and Joint Rule 23A, with the accompanying draft of a bill, to the committee on State Administration. Sent to the Senate for concurrence.

### Message from the Governor —

Reorganization Plan Number 2 of 2003.

A message from His Excellency the Governor submitting (under Article LXXXVII of the Amendments to the Constitution) Reorganization Plan Number 2 of 2003, relative to reforming, restructuring and revitalizing higher education (House, No. 3902) was filed in the office of the Clerk on Thursday, May 15.

The message was read; and it was referred, under Article LXXXVII and Joint Rule 23A, with the accompanying draft of a bill, to the committee on State Administration. Sent to the Senate for concurrence.

## **Emergency Measure.**

The engrossed Bill establishing a sick leave bank for Francie R. Minder, an employee of the Department of Mental Retardation (see House, No. 3736), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 15 to 0. Sent to the Senate for concurrence.

## Reconsideration.

Mr. Rushing of Boston moved that the vote be reconsidered by which the House, on Thursday last, adopted the emergency preamble contained in the engrossed Bill relative to the compensation of certain members of the General Court (see House, No. 3743); and, under Rule 54, the motion to reconsider was placed in the Orders of the Day for the next sitting.
