Pending the question on passing the bill to be engrossed, Mr. Straus of Mattapoisett moved that it be amended in section 1, in line 5, by striking out the figures "90" and inserting in place thereof the figures "60".

The amendment was adopted; and the bill (House, No. 4243, amended) was passed to be engrossed. Sent to the Senate for con-currence.
