The message was read; and, under House Rule 12, it was placed in the Orders of the Day for the next sitting, the question being on passing the bill, notwithstanding the said objections.

Correctional facilities. inspection reports.

Rockland. liquar license.

A petition (accompanied by bill, Senate, No. 2730) of Michael W. Morrissey and Robert J. Nyman (by vote of the town) for legislation to authorize the town of Rockland to issue an additional license for the sale of all alcoholic beverages not to be drunk on the premises, was referred, in concurrence, to the committee on Consumer Protection and Professional Licensure.

Reports of Committees.

Bunker Hill Community College.

By Mr. DeLeo of Winthrop, for the committee on Ways and Means, that the Bill authorizing certain borrowing by Bunker Hill Community College (Senate, No. 2729) ought to pass. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Donato of Medford, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. O'Flaherty of Chelsea, the bill was read a second time forthwith; and it was ordered to a third reading.

Subsequently, under suspension of the rules, on further motion of the same member, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed, in concurrence.

Charles

By Mr. Donato of Medford, for the committee on Steering, Policy and Scheduling, that the House Bill to create a Charles River water

quality commission (House, No. 4683) be scheduled for consideration by the House for a second reading, with amendments previously recommended by the committee on Ways and Means pending.

Under suspension of Rule 7A, on motion of Ms. Wolf of Cambridge, the bill was read a second time forthwith.

The amendments recommended by the committee on Ways and Means then were adopted; and the bill (House, No. 4683, amended) was ordered to a third reading.

Mr. Scaccia of Boston, for the committee on Rules, on House voter Order No. 5001, reported, in part, a Bill relative to voter registration registration for program participants (House, No. 65). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Engrossed Bill.

The engrossed Bill relative to the Massachusetts Insurers Insolvency Fund (see House, No. 5216, amended) (which originated in enacted. the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Motion to Discharge the Committee on Rules.

Before proceeding to consideration of the Orders of the Day, General Mr. Peterson of Grafton moved that the committee on Rules be discharged from further consideration of the House Order relative to sessions. the suspension of Joint Rule 12A to permit the General Court to meet in formal sessions for the purpose of considering and taking action on certain matters (House, No. 5322); and the motion to discharge was negatived.

Orders of the Day.

The Senate Bill establishing the Freedom's Way Heritage Area Third and Commission (Senate, No. 1852, amended), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

The House Bill relative to the payment of pensioners for services n after retirement (House, No. 263) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

The Senate Bill relative to rates of pilotage for the port of Boston Pilotage (Senate, No. 2391, amended) (its title having been changed by the rates. committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, in concurrence, Mr. Smizik of Brookline moved that it be amended by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 5324.

Next sitting. The amendment was adopted; and the bill (Senate, No. 2391, amended) was passed to be engrossed, in concurrence. Sent to the Senate for concurrence in the amendment.
