A Communication from the Execuive Office of Transportation (under Section 7V of Chapter 90 of the General Laws) submitting proposed regulations by the Registry of Motor Vehicles (House. No. 4850) was referred to the committee on Transportation. Sent to the Senate for concurrence.

A petition (accompanied by bill, Senate, No. 2741) of Marc R. Pacheco and Susan W. Gifford (by vote of the town) for legislation to authorize the town of Wareham to issue eight (8) additional licenses for the sale of all-alcoholic beverages to be drunk on the premises, was referred, in concurrence, to the committee on Consumer Protection and Professional Licensure.

Reports of Committees.

By Mrs. Walrath of Stow, for the committee on Health Care fraid. Financing, asking to be discharged from further consideration of the Bill to prevent prescription fraud (House, No. 2173),— and recommending that the same be referred to the committee on Ways and Means. Under Rule 42, the report was considered forthwith; and it was accepted.

Prescription

By Mr. O'Flaherty of Chelsea, for the committee on Judiciary, on Albrecht, a petition, a Bill establishing a sick leave bank for Tracey Albrecht, an employee of the Trial Courts (House, No. 4843). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Donato of Medford, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Ms. L'Italien of Andover, the bill was read a second time forthwith; and it was ordered to a third reading.

Subsequently, under suspension of the rules, on motion of Mr. Dempsey of Haverhill, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time, its title having been changed by said committee to read: "An Act establishing a sick leave bank for Tracey Albrecht, an employee of the Trial Court.".

Pending the question on passing the bill to be engrossed, Mr. Dempsey moved that it be amended by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the trial court, therefore it is hereby declared to be emergency law, necessary for the immediate preservation of the public convenience.".

The amendment was adopted; and the bill (House, No. 4843, amended) was passed to be engrossed. Sent to the Senate for concurrence.

By Mr. Flynn of Bridgewater, for the committee on Bonding, improvement. Capital Expenditures and State Assets, that the Bill providing for the preservation and improvement of land, parks, and clean energy in the Commonwealth (House, No. 4561) ought to pass with an amendment substituting therefor a bill with the same title (House, No. 4847). [Total Bond Authorization: \$1,613,680,000.00]. Referred, under Rule 33, to the committee on Ways and Means, with the amendment pending.
