By the same member, for the same committee, on a petition, a Bill protecting the city of Revere's vehicular rental surcharge from the opening of the consolidated rental car facility at Logan International Airport (House, No. 3709, changed by adding the following three sections: "SECTION 3. For any car rental company or franchise office relocating from Revere to the ConRAC facility which has a franchise or facility at Logan, such car rental company shall determine, based upon information from the calendar year immediately preceding the year of relocation to the ConRAC facility, the percentage of the total combined Revere and Logan vehicular rental transactions that were Revere based, and then shall impose a \$10.00 surcharge, for the sole benefit of the City of Revere, on that same percentage of its vehicular rental transactions occurring at the ConRAC facility each year. This \$10.00 surcharge for the benefit of Revere shall be in lieu of the Boston Convention Center Financing vehicular surcharge imposed by Chapter 152, §9(e) of the Acts of 1997. SECTION 4. The \$10.00 surcharge set forth in Sections 2 and 3 above shall be paid to, and administered by, the commissioner of revenue in accordance with Chapter 92, §§2, 3 of the Acts of 2005. All provisions of said Chapter 92, Sections §§2, 3 of the Acts of 2005 shall apply to the surcharges set forth in this legislation. SECTION 5. This act shall take effect upon its passage." Paxton. By the same member, for the same committee, on a petition, a Bill relative to the town of Paxton (House, No. 4041) [Local Approval Received].

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Emergency Measures.

Mary F. Keeler,—sick leave bank. The engrossed Bill establishing a sick leave bank for Mary F. Keeler, an employee of the Trial Court (see House, No. 1138), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 6 to 0. Sent to the Senate for concurrence.

The engrossed Bill establishing a sick leave bank for Gayle Tickel, an employee of the Department of Correction (see House, No. 1155, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 8 to 0. Sent to the Senate for concurrence.

The engrossed Bill providing for reporting dates for capital gains revenue and transferring certain funds (see House, No. 4142, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 7 to 0. Sent to the Senate for concurrence.

Engrossed bills.

The engrossed Bill validating a certain vote taken by the town of Foxborough (see House bill printed in House, No. 4161) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted (more than two-thirds of the members having agreed to pass the same); and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill establishing a sick leave bank for Michelle Nocera, an employee of the Middlesex Sheriff's Office (see House, No. 1150) (which originated in the House), in respect to which the Senate had concurred in adoption of the emergency preamble, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
