Senators Rosenberg, Spilka, Hart and Tarr were appointed on the part of the Senate; and Representatives Peisch of Wellesley, Donato of Medford, Pignatelli of Lenox, Frost of Auburn, D'Emilia of Bridgewater and Lewis of Winchester were appointed on a part of the House.

We pray for the Governor of this Commonwealth — one man in an intensely solitary position who bears an extraordinary responsibility for so many.

Surround him with support, encouragement and creative minds stimulated to raise new questions and new possibilities that will improve our common life.

Open his mind to hear those who agree and those who challenge
