Casino, liquor license advantage study. Of the Alcoholic Beverages Control Commission established (under Section 106 of Chapter 194 of the Acts of 2011) to conduct a study on whether 204 C.M.R. 4.00, et seq. shall be updated or amended in order to protect licensees under section 12 of chapter 138 of the General Laws from unfair competition with gaming establishments that are granted gaming beverage licenses in the Commonwealth; and

Of the Zero-Based Budget Commission established (under Section 130) of Chapter 165 of the Acts of 2012) to consider and make recommendations concerning the feasibility of transitioning to a zero-based budget for the fiscal year beginning on July 1, 2016;

Mr. Binienda of Worcester, for the temporary committee on Rules, reported (under the provisions of House Rules 7B and 7C) an Order relative to special procedures for consideration of the House Bill making appropriations for the fiscal year 2013 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 55) (for order, see House, No. 56). The order was considered forthwith; and it was adopted.

Supplemental appropriation.

By Mr. Dempsey of Haverhill, for the temporary committee on Id. Ways and Means, on House, No. 43, reported, in part, a Bill making appropriations for the fiscal year 2013 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 55) [Total appropriations: \$115,146,334.00], which was read.

Under suspension of the rules, on motion of the same member, the bill was read a second time forthwith; and it was ordered to a third reading.
