Deane Smith, sick leave. missions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 3400) [Total appropriation: \$38,826,200,824.00]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Subsequently Mr. Coppinger of Boston, for said committee, reported that the matter be scheduled for consideration by the House; and, under the provisions of House order No. 3399, the bill was placed in the Orders of the Day for Monday, April 22, for a second reading.

By Ms. Peisch of Wellesley, for the committee on Education, on a petition, a Bill relative to the financial condition of the Spencer-East Brookfield Regional School District (House, No. 3409).

By Mr. Naughton of Clinton, for the committee on Public Safety and Homeland Security, on a petition, a Bill establishing an emergency equipment grant program for firefighters (House, No. 2116).

By the same member, for the same committee, on a petition, a Bill to jet ski safety (House, No. 2117).

By the same member, for the same committee, on a petition, a Bill establishing the Massachusetts child AMBER Alert plan (House, No. 2160).

By Mr. Kocot of Northampton, for the committee on State Administration and Regulatory Oversight, on a petition, a Bill relative to the conveyance of real property by the Commonwealth in the town of Falmouth (House, No. 2853).

By the same member, for the same committee, on a petition, a Bill relative to Congo conflict minerals (House, No. 2898).

Severally read; and referred, under Rule 33, to the committee on Ways and Means.

By Ms. Peake of Provincetown, for the committee on Municipalities and Regional Government, on a joint petition, a Bill amending the charter of the town of Abington (House, No. 3355) [Local Approval Received].

By the same member, for the same committee, on a petition, a Bill relative to the capital investment fund of town of Sterling (House, No. 3357) [Local Approval Received].

By the same member, for the same committee, on a petition, a Bill authorizing the town of Framingham to place municipal charge liens on certain properties in the town of Framingham for nonpayment of any local charges, fee or fine (House, No. 3358) [Local Approval Received].

By the same member, for the same committee, on Senate No. 951 and House, No. 3232, a Bill authorizing the town of Hingham to change the use of certain parcels of land in the town (House, No. 3411) [Local Approval Received].

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

## Emergency Measure.

The engrossed Bill establishing a sick leave bank for Deane Smith, an employee of the Department of Correction (see House, No. 2292), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 4 to 0. Sent to the Senate for concurrence.

# Orders of the Day.

The Senate Bill establishing a sick leave bank for Celia Gentile, and employee of the Department of Correction (Senate, No. 1753), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

The House Bill establishing a sick leave bank for Irene Archambault, an employee of the Trial Court (House, No. 3380) was read a third time.

The committee on Bills in the Third Reading reported recommending that the bill be amended by adding the following sentence: "Sick leave bank days shall not be used for absences unrelated to the illness or disability that necessitated the establishment of the sick leave bank as determined by the trial court.". The report was accepted.

The amendment then was adopted; and the bill (House, No. 3380, amended) was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill designating the former Canton Airport site as the 1st Lt. Arthur E. Farnham, Jr., and SSgt. Thomas M. Connolly, Jr. Memorial Park, Neponset River Reservation (House, No. 704), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time. Pending the question on passing the bill to be engrossed, Mr. Galvin of Canton moved to amend it in line 3 by striking out the following: "1st Lt." and inserting in place thereof the following: "Lt Col", in said line 3 by striking out the following: "SSgt." and inserting in place thereof the following: "TSgt", in line 5 by striking out the word "Forces" and inserting in place thereof the word "Force"; and by striking out the title and inserting in place thereof the following title: "An Act designating the former Canton Airport site as the Lieutenant Colonel Arthur E. Farnham, Jr. and Technical Sergeant Thomas M. Connolly, Jr. Memorial Park, Neponset River Reservation.".

The amendments were adopted; and the bill (House, No. 704, amended) was passed to be engrossed. Sent to the Senate for concurrence.
