Governor notified.

Ordered, That a special committee of the House be appointed to wait upon His Excellency the Governor and inform him that Representatives-elect Leah Cole of the Twelfth Essex District and Wayne A. Matewsky of the Twenty-eighth Middlesex District are assembled in the Chamber of the House of Representatives and are ready to take the oaths and affirmations of qualification.

The Speaker then appointed Representatives Donato of Medford, Speliotis of Danvers, Ashe of Longmeadow, Vega of Holyoke, Roy of Franklin, Orrall of Lakeville, Cusack of Braintree, Naughton of Clinton, Wong of Saugus, Hunt of Sandwich, Vieira of Falmouth and Gifford of Wareham as the special committee of the House.

Members Qualified.

Representatives Leah Cole of Peabody and Wayne A. Matewsky of Everett, qualification. Soon afterward His Excellency the Governor, Deval L. Patrick, accompanied by Lieutenant Governor Timothy P. Murray, Auditor Suzanne M. Bump and members of the Honorable Council came in; the oaths and affirmation required by the Constitution and laws was administered by the Governor to the members-elect then present, and were subscribed by them; after which His Excellency declared that the members were duly qualified to enter upon the discharge of their duties.

His Excellency the Governor, Lieutenant Governor Timothy P. Murray, Auditor Suzanne M. Bump and the Honorable Councillors present then departed the Chamber under escort of the Sergeant-at-Arms.

After brief remarks by both newly qualified members, the Speaker assigned Ms. Cole to Seat No. 76 and Mr. Matewsky to Seat No. 37.

National Guard, life insurance premiums. Carmen Berry, sick leave. By Mr. Michlewitz of Boston, for the committee on Public Service, on a petition, a Bill establishing a sick leave bank for Carmen Berry, an employee of the Department of Children and Families (House, No. 3443).

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Emergency Measure.

John Gustavis, sick leave. The engrossed Bill establishing a sick leave bank for John Gustavis, an employee of the Hampshire Sheriff's Office (see House, No. 3417), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 10 to 0. Sent to the Senate for concurrence.
