The message was read; and it was referred, under Rule 17G, with the accompanying draft of a bill, to the committee on Bonding, Capital Expenditures and State Assets.

Petitions

Mr. Naughton of Clinton presented a petition (subject to Joint Rule 12) of Harold P. Naughton, Jr., relative to benefits for those who have served in the armed forces of the United States in active service as part of Operation Enduring Freedom, Operation Iragi Freedom, or Operation Noble Eagle and who were discharged or released under honorable conditions from such service; and the same was referred, under Rule 24, to the committee on Rules.

Mr. Binienda of Worcester, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, then reported recommending that Joint Rule 12 be suspended. Under suspension of the rules, on motion of Mr. Matewsky of Everett, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Veterans and Federal Affairs. Sent to the Senate for concurrence.

By Mr. Lombardo of Billerica, a petition (subject to Joint Rule 12) of Marc T. Lombardo for legislation to provide tax incentives to increase safety and security in schools.

Severally, under Rule 24, to the committee on Rules.

A petition (subject to Joint Rule 9) of Tackey Chan for legislation to exempt the Massachusetts Municipal Wholesale Electric Company from certain laws regulating public construction (having been returned by the State Secretary with a letter stating that the petitioner had failed to file proof of notice of publication), was placed on file.

Papers from the Senate.

The House Bill making appropriations for the fiscal year 2014 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 3401), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 1800.

Under suspension of the rules, on motion of Mr. Dempsey of Haverhill, the amendment was considered forthwith. The House then non-concurred with the Senate in its amendment; and, on further motion of the same member, asked for a committee of conference on the disagreeing votes of the two branches. Messrs. Dempsey, Kulik of Worthington and deMacedo of Plymouth were appointed the committee on the part of the House. Sent to the Senate to be joined.

Subsequently notice was received from the Senate that said branch had insisted on its amendment, concurred with the House in the appointment of a committee of conference; and that Senators Brewer, Flanagan and Knapik had been joined as the committee on the part of the Senate.

The House Bill relative to the financial condition of the Spencer-East Brookfield Regional School District (House, No. 3476), came from the Senate passed to be engrossed, in concurrence, with amendments in section 1, in line 3, after the word "education", in line 4, after the word "revenue" and in line 7, after the word "finance", inserting, in each instance, the words ", or a designee"; in section 2, in lines 8 and 9, in section 3, in lines 28 and 29, in section 6, in lines 86 and 87 and in section 8, in line 142, striking out, in each instance, the words "or regional school district agreement"; in section 7, in lines 123 and 124, striking out the words "or a single justice of the supreme judicial court"; and in section 9, in line 195, striking out the following: "June 30, 2013, or such earlier date" and inserting in place thereof the following: "or before June 30, 2013 for fiscal year 2013,".

The amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

A petition (accompanied by bill) of Richard J. Ross for legislation relative to disability insurance benefits, came from the Senate referred, under suspension of Joint Rule 12, to the committee on Financial Services.
