Notice was received that the Senate had (on April 22, 2013) insisted on its amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 1770) (in which the House had non-concurred) of the House Bill relative to transportation finance (House, No. 3415).

Transportation finance.

The bill bore the further endorsement that said branch had concurred with the House in the appointment of a committee of conference on the disagreeing votes of the two branches; and that Senators Brewer, McGee and Hedlund had been appointed the committee on the part of the Senate.

Committee of conference.

A Bill designating the month of May as Blue Star Mothers month (Senate, No. 1521) (on a petition), passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A petition (accompanied by bill, Senate, No. 1784) of Thomas M. McGee, Robert F. Fennell, Steven M. Walsh, Lori A. Ehrlich and other members of the General Court (with the approval of the mayor and city council) for legislation to authorize the city of Lynn to establish a program for enforcement against illegal dumping, was referred, in concurrence, to the committee on Municipalities and Regional Government.
