The Senate Bill authorizing the Wilkinsonville Water District to convey a certain parcel of land (Senate, No. 1995, amended), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

Second reading bill amended.

The amendment previously recommended by the committee on Health Care Financing,— that the bill be amended by substitution of a bill with the same title (House, No. 4096),—was adopted; and the substituted bill was ordered to a third reading.

The House Bill relative to pesticide licensing and mosquito control Pesticide (House, No. 3568), reported by the committee on Bills in the Third Reading be correctly, was read a third time.

licensing.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in section 5, in line 49, by inserting after the word "sought." the following sentence: "Upon a determination that the applicant has satisfied the criteria established or that certification, license or permit, the department shall immediately issue a temporary certification, license or permit to be valid until the applicant is in receipt of a permanent certificate, license or permit."; and in said section 5 by adding the following paragraph:

"(i) The department may impose an administrative or civil penalty on a person, who has not been issued either a temporary or permanent certification, license or permit from the department, who uses a pesticide in a public or private place used for human occupation and habitation, except residential properties with 3 or less dwelling units, of not more than \$500 for a first offense and not more than \$1,000 for any subsequent offense."; and by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of correction, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.".

The amendments were adopted; and the bill (House, No. 3568, amended) was passed to be engrossed. Sent to the Senate for concurrence.
