The message was read; and it was referred under Rule 30, with the accompanying draft of a bill, to the committee on Ways and Means.

Subsequently Mr. Dempsey of Haverhill, for said committee, reported on the foregoing message, a Bill making certain appropriations for the fiscal year 2014 before final action on the General Appropriations Bill (printed in House, No. 3523) [Direct Appropriations: \$4,075,000,000]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kafka of Stoughton, for said committee, reported that the matter be scheduled for consideration by the House.
