Engrossed Bills.

The engrossed Bill establishing a sick leave bank for Janet Everett, an employee of the Massachusetts Department of Transportation (see House, No. 3481, amended) (which originated in the House), in respect to which the Senate had concurred in adoption of the emergency preamble, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill authorizing the appointment of William M. Cowl, Id. Jr. as a firefighter in the city of Haverhill notwithstanding the maximum age requirement (see House, No. 3227) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
