Retiree health care, study. By Mr. Peterson of Grafton, a petition (subject to Joint Rule 12) of George N. Peterson, Jr., providing for an investigation and study by a special commission (including members of the General Court) relative to the feasibility of allowing municipalities to offer their retirees individual policies funded by health reimbursement arrangements.

Tammy S. Storey, sick leave. By Mr. Smola of Warren, a petition (subject to Joint Rule 12) of Todd M. Smola and Stephen M. Brewer for legislation to establish a sick leave bank for Tammy S. Storey, an employee of the Department of Developmental Services.

# Papers from the Senate.

Municipal collaboration.

The House Bill promoting municipal collaboration and regionalization throughout the Commonwealth (House, No. 3822), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 1, in line 6, inserting after the word "constituted," the words "the Hampshire council of governments". The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

Privacy protections.

A Bill updating privacy protections for personal electronic information (Senate, No. 2299) (on Senate, No. 796), passed to be engrossed by the Senate, was read; and it was referred, under Rule 33, to the committee on Ways and Means.

Establishing uniform wage compliance record keeping (Senate, No. 858) (on a petition);

Westfield, road. Relative to the acceptance of Paper Mill road as a public way in the city of Westfield (Senate, No. 2169) (on a petition) [Local Approval Received];

Relative to improving notice requirements for self-storage (Senate, No. 2297) (on Senate bill No. 183); and

Establishing a tay title collection ravelying fund (Senate, No. 2208)

Tax title, fund. Establishing a tax title collection revolving fund (Senate, No. 2298) (on Senate bill No. 934);

Severally passed to be engrossed by the Senate, were read; and they were referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

#### Reports of Committees.

By Mr. Kafka of Stoughton, for the committee on Steering, Policy and Scheduling, that the report of the committee of conference on the disagreeing votes of the two branches, with reference to the House amendment (striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 3601, amended) of the Senate Bill further regulating mercury management (Senate, No. 1758, amended), recommending passage of a bill with the same title (Senate, No. 2303), be scheduled for consideration by the House, the question being on acceptance.

Mercury management.

Under suspension of the rules, on motion of Ms. Gobi of Spencer, the report was considered forthwith; and it was accepted, in concurrence.

By Mr. Kocot of Northampton, for the committee on State Administration and Regulatory Oversight, on a joint petition, a Bill relative to preserving a memorial to landing ship tanks in the town of Hingham (House, No. 4232).

The committee on Bills in the Third Reading reported recommending the House non-concur with the Senate in its amendment; and the report was accepted.

The House then non-concurred with the Senate in its amendment. The bill then was sent to the Senate for its action.

Third reading bill amended.

Pending the question on passing the bill to be engrossed, Mr. McMurtry of Dedham moved to amend it by substitution of a bill with the same title (House, No. 4347), which was read.

The amendment was adopted; and the substituted bill was passed to be engrossed. Sent to the Senate for concurrence.
