Of the special commission established (under Section 59 of Chapter 176 of the Acts of 2011 and most recently revived and continued by Section 30 of Chapter 36 of the Acts of 2013) to investigate and study all aspects of the ordinary and accidental disability provisions of the Massachusetts contributory retirement system as well as the provisions of injured on duty benefits and presumptions for public employees contained in the General Laws; and

Of the Water Resource Commission (pursuant to Section 8C of Chapter 21 of the General Laws) submitting an amendment to the Interbasin Transfer Approval Foxborough Witch Pond Wells dated July 11, 2013; and

The annual report of the University of Massachusetts (under Section 15 of Chapter 75 of the General Laws) illustrating the accountability, assessment, improvement and continued progress of the UMass system;

Severally were placed on file.

## Papers from the Senate.

The House Bill relative to financing the production and preservation Housing. of housing for low and moderate income residents (House, No. 3492, amended), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 1845.

Under suspension of Rule 35, on motion of Mr. Dempsey of Haverhill, the amendment was considered forthwith.

The House then non-concurred with the Senate it is amendment; and, on further motion of the same member, asked for a committee of conference on the disagreeing votes of the two branches. Representatives Dempsey, Honan of Boston and Smola of Warren were appointed to the committee on the part of the House. Sent to the Senate to be joined.

The House Bill eliminating the preliminary elections in the city of Malden,— Malden in 2013 (House, No. 3591), came from the Senate passed to be engrossed, in concurrence, with an amendment adding the following section:

election.

"SECTION 2. This act shall take effect upon its passage.".

The amendment (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was considered forthwith; and it was adopted, in concurrence.

The House Bill authorizing the town of Wellesley to convey a certain parcel of land (House, No. 3513) (its title having been changed by the Senate committee on Bills in the third Reading), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 1, in line 1, striking out the words "Notwithstanding the provisions of any general or special law to the contrary" and inserting in place thereof the following: "Notwithstanding section 4 of chapter 267 of the acts of 2002 or any other general or special law to the contrary". The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

Wellesley,-

A Bill relative to the release of a body by the medical examiner to a person charged with an offense which resulted in the death of the deceased (Senate, No. 1099, changed in line 8 after the word "an", by striking out the word "intentional" and in lines 9 and 10 by striking out the words "; provided further that such person shall be disqualified from acting as executor or administrator of the estate of the deceased" and amended in lines 5 and 6 by striking out the following: "if such person is aged 18 years old or older,") (on a petition), passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A report of the committee on Transportation, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 1713) of Bruce E. Tarr, Bradley H. Jones, Jr., and Michael R. Knapik for legislation to include Federal Law Enforcement Officers as police officers, and recommending that the same be referred, to the committee on Public Safety and Homeland Security,— accepted by the Senate, was considered forthwith, under Rule 42; and it was accepted, in concurrence.

Petersham, debt limit. A petition (accompanied by bill, Senate, No. 1844) of Stephen M. Brewer, Denise Andrews and Anne M. Gobi (by vote of the town) for legislation to authorize the town of Petersham to borrow outside the debt limit for a certain town project, was referred, in concurrence to the committee on Municipalities and Regional Government.

Fall River,—

A petition (accompanied by bill) of Michael J. Rodrigues and Alan Silvia for legislation to authorize the Massachusetts Department of Transportation to acquire certain parcels of land in the city of Fall River, came from the Senate referred, under suspension of Joint Rule 12, to the committee on State Administration and Regulatory Oversight.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 1847) was referred, in concurrence, to the committee on State Administration and Regulatory Oversight.
