A-B-C Flood Board. A Bill extending the Environmental Joint Powers Agreement that created the A-B-C Stormwater Flooding Board (Senate, No. 1857) (on Senate bill No. 343); and

Housing,—accessibility.

A Resolve providing for an investigation and study by a special commission relative to the need for accessible homes for the elderly, returning veterans with disabilities and families that include persons with disabilities (Senate, No. 1787) (on Senate bill No. 601);

Severally passed to be engrossed by the Senate, were read; and they were referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Severally having been certified by the Clerk to be rightly and truly

prepared for final passage, were passed to be enacted.

Quorum.

Mr. Lyons of Andover thereupon asked for a count of the House to ascertain if a quorum was present. The Chair (Mr. Donato of Medford) determined that a quorum was not in attendance. Inasmuch as a quorum was not in attendance when the previous votes were taken on severally passing the bills to be enacted, the votes, in each instance, were declared void.
