Silent Prayer.

At the request of Mr. Rushing of Boston and Ms. Fox of Boston, the members, guests and employees stood in a moment of silent tribute to the memory of Joyce Foster of Boston, who passed away on August 10, 2013, surrounded by her sons, Pacey, Matt and Ned Foster. Ms. Foster served the Fenway and Roxbury communities of Boston as an advocate for economic and social justice. Ms. Foster owned a consulting company for twenty years, through which she worked with business, nonprofit and academic institutions. She devoted her retirement to service to her community. As a board member for the Fenway Community Development Corporation, Ms. Foster worked tirelessly to preserve affordable housing in the Fenway and Lower Roxbury. Beginning in 2005, Ms. Foster served on the Northeastern University Community Task Force, through which she worked to ensure that the university maintained a regular dialogue with its surrounding neighborhoods regarding the university's impact on those communities. Determined that her community should have a voice, Ms. Foster served for several years as president of the board of the Fenway News. The Fenway Community Development Corporation described Ms. Foster as "a force of nature".

Motion to Suspend Rule 24(2).

Mr. Winslow of Norfolk then moved that Rule 24(2) be suspended so that he might offer, from the floor, the following order:—

Ordered, That the Rules of the House of Representatives be amended, in House Rule 12, in line 154, by striking the words "formal session" and inserting in place thereof the word "sessions"; in lines 169 and 170, by striking the sentence "The Clerk shall dispense with preparing and making available a Calendar for designated Informal Sessions of the House."; in lines 171 through 174, inclusive, by striking the sentence "As soon as practicable whenever the Clerk prepares a Calendar or advance Calendar under this rule, he also shall cause a true copy thereof to be posted on the Legislative Web Page that is generally available to all members and their staff, and reasonably promptly thereafter he shall cause the members and their staff to be notified of the same by way of electronic mail.", and inserting in place thereof, the following:-

"Whenever the Clerk prepares a Calendar or advance Calendar under this rule, he also shall cause a true copy thereof, including

House Rules. hyperlinks to all items contained therein, to be posted on the Legislative Web Page that is generally available to all members and their staff, and reasonably promptly thereafter he shall cause the members and their staff to be notified of the same by way of electronic mail, but by no later than a half an hour preceding the start of an informal or formal session of the House."; and by adding at the end of said rule the following paragraph:

"Not less than 15 minutes prior to the convening of each session, the Clerk shall also make available by electronic mail transmission to all members of the House and legislative staff a list of all miscellaneous papers to be considered during that session including, but not limited to, reports of committees, engrossed bills, messages from the Governor and papers from the Senate."
