Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Pledge of allegiance.

Resolutions.

Petition.

Palmer, fire and water district. Mr. Smola of Warren presented a petition (subject to Joint Rule 12) of Todd M. Smola and Stephen M. Brewer for legislation to increase the amount of money that may be borrowed by the Thorndike Fire and Water District in the town of Palmer; and the same was referred, under Rule 24, to the committee on Rules.

Reports of Committees.

Diesel engines, study. By Ms. Gobi of Spencer, for the committee on Environment, Natural Resources and Agriculture, on House, No. 679, an Order relative to authorizing the committee on Environment, Natural Resources and Agriculture to make an investigation and study of a certain House document concerning Diesel engines (House, No. 4479) [Senator Brownsberger dissenting].

Zoning, study. By the same member, for the same committee, on House, No. 691, an Order relative to authorizing the committee on Environment, Natural Resources and Agriculture to make an investigation and study of a certain House document concerning zoning (House, No. 4480).

Dairy products, study. By the same member, for the same committee, on House, No. 782, an Order relative to authorizing the committee on Environment, Natural Resources and Agriculture to make an investigation and study of a certain House document concerning dairy (House, No. 4481).

Pesticides, study. By the same member, for the same committee, on House, No. 3594, an Order relative to authorizing the committee on Environment, Natural Resources and Agriculture to make an investigation and study of a certain House document concerning pesticides (House, No. 4482) [Senator Brownsberger dissenting].

Revenue, study. By Mr. Kaufman of Lexington, for the committee on Revenue, on House, Nos. 80, 4130 and 4174, an Order relative to authorizing the committee on Revenue to make an investigation and study of certain House documents concerning revenue issues (House, No. 4483).

Severally referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.

Ms. Hogan of Stow, for said committees, reported, in each instance, asking to be discharged from further consideration of the orders; and recommending that the same severally be referred to the House committee on Rules.

Under Rule 42, the reports severally were considered forthwith; and they were accepted.

Emergency Measure.

Timothy Maxfield, sick leave. The engrossed Bill establishing a sick leave bank for Timothy Maxfield, an employee of the Department of Developmental Services (see Senate, No. 2369), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 6 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Engrossed Bills.

The engrossed Bill establishing a sick leave bank for Tracy Longvall-Rivera, an employee of the Department of Youth Services (see House, No. 3904) (which originated in the House), in respect to which the Senate had concurred in adoption of the emergency preamble, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate

enacted.

The engrossed Bill validating the results of a certain election held in Id. the town of Lancaster (see House bill printed in House, No. 4331) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted (more than two-thirds of the members having agreed to pass the same); and it was signed by the acting Speaker and sent to the Senate.

Engrossed bills

Establishing the metrowest commission on the status of women (see Bills Senate, No. 1920, amended):

enacted.

Relative to the charter of the town of Bellingham (see Senate, No. 2066);

(Which severally originated in the Senate); and

Relative to certain municipal salaries in the city of Lynn (see House, No. 4335) (which originated in the House);

Severally having been certified by the Clerk to be rightly and truly prepared for final passage, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Orders of the Day.

The Senate Bill authorizing the abatement of a certain sewer betterment assessment in the town of Sturbridge (Senate, No. 2140), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

Third reading bill

The House Bill relative to the town of Fairhaven establishing the position of town administrator (House, No. 4129), was read a third time

Third reading bill amended.

The committee on Bills in the Third Reading reported recommending that the bill be amended by substitution of a Bill establishing the position of town administrator in the town of Fairhaven (House, No. 4478); and the report was accepted.

The amendment was adopted; and the substituted bill was passed to be engrossed. Sent to the Senate for concurrence.

Commissioner of Banks,— investments.

The Senate amendments of the House Bill relative to the list of legal investments prepared by the Commissioner of Banks (House, No. 3954, amended), reported by the committee on Bills in the Third Reading to be correctly drawn, were considered.

Mr. Speliotis of Danvers moved that the House concur with the Senate in its amendments with a further amendment by striking out section 5. The further amendment was adopted.

The House then concurred with the Senate in its amendments, as amended. Sent to the Senate for concurrence in the further amendment.

Whatley,— Donald Dufault and John DuBois. The House Bill authorizing the town of Whately to continue the employment of Donald Dufault and John DuBois (House, No. 4222, amended), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Kulik of Worthington moved to amend it by striking out section 1 and insert-

ing in place thereof the following section:

"SECTION 1. Notwithstanding any general or special law to the contrary, Donald Dufault, firefighter for the fire department of the town of Whately and John DuBois, firefighter for said fire department, may continue to serve in such positions until the age of 70, until the date of their retirement or non-reappointment, whichever occurs first. No further deductions shall be made from the regular compensation of Donald Dufault or John DuBois for any service performed subsequent to their reaching the age of 65 in connection with their service to the town for retirement or pension purposes under chapter 32 of the General Laws."

The amendment was adopted; and the bill (House, No. 4222, amended) was passed to be engrossed. Sent to the Senate for concurrence.
