Petition

Representative Naughton of Clinton and Senator Chandler presented a joint petition (accompanied by bill, House, No. 4507) of Harold P. Naughton, Jr., Harriette L. Chandler and Jennifer L. Flanagan (by vote of the town) that the board of selectmen of the town of Clinton be authorized to appoint the town collector for said town; and the same was referred to the committee on Municipalities and Regional Government. Sent to the Senate for concurrence.

Papers from the Senate.

The House Bill relative to the board of selectmen-town manager form of government in the town of Great Barrington (House, No. 4192), came from the Senate passed to be engrossed, in concurrence, with amendments in section 1, in line 28, striking out the word "may" and inserting in place thereof the word "shall", and in line 83, inserting after the word "hearing" the following: "; provided, however, that if the town manager does not reply to the resolution within 7 days, the selectboard may proceed to final action 30 days after the preliminary resolution". The amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

Barrington, form of government.

The Senate Bill relative to the Department of Inspectional Services in the city of Lynn (Senate, No. 2276) (on a petition) [Local Approval Received], passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Reports of Committees.

Supplemental appropriations.

Mr. Dempsey of Haverhill, for the committee on Ways and Means, on House, No. 4301, reported, in part, a Bill making appropriations for the fiscal year 2014 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 4504) [Total appropriation: \$77,846,680.00]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kafka of Stoughton, for said committee, reported that the matter

be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Smizik of Brookline, the bill was read a second time forthwith; and it was ordered to a third reading.

Subsequently, the noon recesses having terminated, under further suspension of the rules, on motion of Mr. Dempsey of Haverhill, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time.

Pending the question on passing the bill to be engrossed, Messrs. Jones of North Reading and Dooley of Norfolk moved to amend it by

adding the following section:

"SECTION 73. Section 2A of chapter 79 of the acts of 2014 is hereby amended by inserting, in item 6121-1317, after the words 'town of Marion', the following:—; provided further, that not less than \$500,000 shall be expended to study the replacement of the Main Street Bridge and the Lawrence Street Bridge in the Town of Norfolk."

The amendment was adopted.

Mr. Dempsey of Haverhill then moved to amend the bill

In section 2, in item 1599-0026, by striking out the figures "\$200,000 and inserting in place thereof the figures "\$600,000";

By inserting after section 5A (inserted by the committee on Bills in

the Third Reading) the following two sections:

"SECTION 5B. Section 22 of chapter 13 of the General Laws, as appearing in section 2 of chapter 159 of the acts of 2014, is hereby amended by striking out, in lines 13, 19, 25, 28, 31 and 35, the words:— at least.

SECTION 5C. Subsection (i) of said section 22 of said chapter 13, as so appearing, is hereby amended by adding the following sentence:— The registered pharmacist as defined in subsection (g) shall not constitute an appointment of an independent pharmacist, chain pharmacist, hospital pharmacist, long-term care pharmacist, or academic pharmacist as defined in subsections (c), (d), (e), (f), and (h) for the purposes of this paragraph.";

By inserting after section 22 the following section:

"SECTION 22A. Subsection (c) of section 39F of chapter 112 of the General Laws, as so appearing, is hereby amended by striking out the word 'pharmacies' and inserting in place thereof the following word:—entities.";

By striking out section 27 and inserting in place thereof the following section:

"SECTION 27. Section 5 of chapter 624 of the acts of 1986, as amended by chapter 165 of the acts of 2014, is hereby amended by striking out the words 'and use of Turtle Lane, a private way, and the

use of a private driveway shall be restricted to emergency access, except that a temporary easement through Turtle Lane shall be authorized for rehabilitation of Elm Bank.";

In section 40, in line 537, by inserting after the word "Boylston" the following: "; provided further, that not less than \$400,000 shall be expended for an infrastructure improvement project in the town of Hatfield";

In section 69 (as published) by adding the following paragraph:

"(70) between the Essex County Sheriffs and the National Corrections Employees Union, Local 121"; and

By adding the following section:

"SECTION 74. Item 7000-9091 of chapter 237 of the act of 2014 is hereby amended by inserting after the word Mendon the following: provided further that \$250,000 shall be expended for improvements to the roof of the Shelbourne Library.".

The amendments were adopted.

The bill, as amended, then was passed to be engrossed. The bill (House, No. 4508, published as amended) then was sent to the Senate for concurrence.
