Dartmouth, special police. A report of the committee on Public Service, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 2363) of Marc C. Montigny and Christopher M. Markey (by vote of the town) for legislation to authorize the appointment of special police officers in the town of Dartmouth, and recommending the same be referred to the committee on Municipalities and Regional Government,— accepted by the Senate, was considered forthwith, under Rule 42; and it was accepted, in concurrence.

Alixis Baez, sick leave. A petition of Harriett L. Chandler and Mary S. Keefe for legislation to establish a sick leave bank for Alixis Baez, an employee of the Worcester Recovery Center and Hospital, came from the Senate referred, under suspension of Joint Rule 12, to the committee on Public Service.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2386) was referred, in concurrence, to the committee on Public Service.
