Ms. Hogan of Stow, for the committee on Rules, on the Order relative to authorizing the committee on Public Service to make an investigation and study of certain House documents concerning public service, retirement and other related issues (House, No. 4189), reported, in part, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 3638) of Wayne Matewsky (with the approval of the mayor, board of alderman and common council) that the city of Everett be authorized to retire Michael Marchese at the rate of compensation which would have been paid to him at the time of his retirement had he continued in service as a police officer in said city,— and recommending that the same be recommitted to the committee on Public Service. Under Rule 42, the report was considered forthwith; and it was accepted.

By Mr. Kaufman of Lexington, for the committee on Revenue, on a petition, a Bill providing that real property owned by Develop Springfield shall be exempt from taxation in the city of Springfield (House, No. 3537) [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Emergency Measure.

The engrossed Bill establishing a sick leave bank for Dean Bassett, an employee of the Executive Office of Labor and Workforce Development (Senate, No. 2391), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 7 to 0. Sent to the Senate for concurrence

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and Senate to the Senate.
