Papers from the Senate.

The House Bill relative to the town manager in the town of Cohasset (House, No. 3486), came from the Senate passed to be engrossed, in concurrence, with amendments in section 4, in line 260, striking out the following: "(c)" (as changed by the House committee on Bills in the Third Reading) and inserting in place thereof the following: "(a)"; and, in lines 267 and 268, striking out the following: "or subsection (c)". The amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

The House Bill establishing a sick leave bank for Laureen Doolan, an employee of the Department of Correction (House, No. 3738, amended), came from the Senate passed to be engrossed, in concurrence, with an amendment in line 4, inserting after the word "Doolan", the first time it appears, the words "to care for her children". The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

A petition of Richard T. Moore, Michael O. Moore, John F. Keenan, Brian A. Joyce and other members of the General Court for legislation to designate June fourteenth as the birthday of the United States Army and June ninth as General Sylvanus Thayer Day, came from the Senate referred, under suspension of Joint Rule 12, to the committee on State Administration and Regulatory Oversight.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 1963) was referred, in concurrence, to the committee on State Administration and Regulatory Oversight.

Reports of Committees.

By Mr. Binienda of Worcester, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the following petitions:

Petition (accompanied by bill) of Randy Hunt for legislation to enhance enforcement of laws banning the delivering of drugs or articles to prisoners in correctional institutions or jails. To the committee on the Judiciary.

Petition (accompanied by bill) of Randy Hunt and others for an investigation by a special commission (including members of the General Court) relative to mandated treatment and monitoring of nonviolent offenders with substance addictions. To the committee on Mental Health and Substance Abuse.

Petition (accompanied by bill) of Jennifer E. Benson and Jennifer L. Flanagan for legislation to establish a sick leave bank for James Cooney, an employee of the Department of Correction. To the committee on Public Service.

Petition (accompanied by bill) of Randy Hunt, Cory Atkins and others for legislation to authorize income tax filers to make voluntary contributions to the Massachusetts Cultural Development Fund on their annual income tax returns. To the committee on Revenue.

Under suspension of the rules, on motion of Mr. Speliotis of Danvers, the reports were considered forthwith. Joint Rule 12 then was suspended, in each instance. Severally sent to the Senate for concurrence.

Severally having been certified by the Clerk to be rightly and truly prepared for final passage, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Bills enacted

Third reading bill.

Third reading bills. Severally reported by the committee on Bills in the Third Reading to be correctly drawn, were read a third time; and they were passed to be engrossed. Severally sent to the Senate for concurrence.

The further amendment of the Senate Bill relative to the release of a body by the medical examiner to a person suspected or charged with an offense which resulted in the death of the deceased (Senate, No. 1099 changed and amended) (reported by the committee on Bills in the Third Reading to be correctly drawn), was considered.

Mr. Speliotis of Danvers then moved that the House concur with the Senate in its further amendment with a still further amendment by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 3820. The still further amendment was adopted.

The House then concurred with the Senate in its amendment, as amended. Sent to the Senate for concurrence in the still further amendments.

The House Bill authorizing the town of Belmont to grant licenses for the sale of wines and malt beverages to be drunk on the premises (House, No. 3780), reported by the committee on Bills in the Third Reading be correctly, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Rogers of Cambridge moved to amend it in lines 7 to 17, inclusive, by striking out the two paragraphs contained in those lines.

The amendment was adopted; and the bill (House, No. 3780, amended) was passed to be engrossed. Sent to the Senate for concurrence.

Emergency Measure.

The engrossed Bill establishing a sick leave bank for Trina Higgins, an employee of the Trial Court (see Senate, No. 1956), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 4 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
