Petition.

Robin Allen, sick leave. Mr. Ashe of Longmeadow presented a petition (subject to Joint Rule 12) of Brian M. Ashe for legislation to establish a sick leave bank for Robin Allen, an employee of the Department of Developmental Services; and the same was referred, under Rule 24, to the temporary committee on Rules.

Mr. Marino of Quincy, for the temporary committee on Rules and the temporary committees on Rules of the two branches, acting concurrently, then reported recommending Joint Rule 12 be suspended. Under suspension of the rules, on motion of Mr. Smola of Palmer, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred, on motion of Mr. Ashe, to the temporary committee on Rules. Sent to the Senate for concurrence in the suspension of Joint Rule 12.

Emergency Measure.

Michele Shuman, sick leave. The engrossed Bill establishing a sick leave bank for Michele Shuman, an employee of the Trial Court (see House, No. 45), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 8 to 0. Sent to the Senate for concurrence.

Bill enacted.

Subsequently, the noon recess having terminated, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
