#### Message from the Governor.

A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation to relative to authorizing the town of Scituate to establish the date of its annual town election (House, No. 55), was filed in the office of the Clerk on Tuesday, February 17.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on the Election Laws. Sent to the Senate for concurrence.
