Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Kafka of Stoughton being in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

At the request of the Chair (Mr. Kafka), the members, guests Pledge of and employees joined with him in reciting the pledge of allegiance allegiance. to the flag.

#### Resolutions.

The following resolutions (filed with the Clerk) were referred, under Rule 85, to the committee on Rules:

Mr. Galvin of Canton, for the committee on Rules, reported, in each instance, that the resolutions ought to be adopted. Under suspension of the rules, in each instance, on motion of Mr. Galvin, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

A Bill relative to the special election in the city known as the town Greenfield, of Greenfield (Senate, No. 20, amended in section 1, in line 2, by striking out the following: "April 14" and inserting in place thereof the following: "May 12") (on a petition) [Local Approval Received], passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

A petition (accompanied by bill, Senate, No. 24) of Brian A. Joyce, Bruce J. Ayers, Mark J. Cusack and Walter F. Timilty (by vote of the town) for legislation to amend the charter of the town of Randolph, was referred, in concurrence, to the committee on Municipalities and Regional Government.

### Reports of Committees.

By Mr. Fernandes of Milford, for the committee on the Judiciary, Paternity. asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 1319) of Colleen M. Garry relative to establishing paternity and establishing uniform procedures for providing information to mothers and certain fathers regarding the benefits and responsibilities of parentage, — and recommending that the same be referred to the committee on Children, Families and Persons with Disabilities. Under Rule 42, the report was considered forthwith; and it was accepted. Sent to the Senate for concurrence.

Read; and referred, under Rule 17G, to the committee on Bonding, Capital Expenditures and State Assets.

By Mr. Fernandes of Milford, for the committee on the Judiciary, on a joint petition, a Bill establishing a sick leave bank for John Morrill, an employee of the Attleboro District Court (House, No. 1368). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

## Orders of the Day.

The House Bill establishing a sick leave bank for Simon Valedi, an employee of the Massachusetts Department of Transportation (House, No. 64) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.
