Malden, stadium, etc. commission. By Mr. O'Day of West Boylston, for the committee on Municipalities and Regional Government, on a petition, a Bill amending the composition of the Stadium and Athletic Field Commission in the city of Malden (House, No. 3194) [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Nangle of Lowell, for said committee, then reported recommending that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of the same member, the bill was read a second time forthwith; and it was ordered to a third reading.

Engrossed Bill.

Municipal roads and bridges.

The engrossed Bill providing for the financing of certain improvements to municipal roads and bridges (see House bill printed in House, No. 3187, amended) (which originated in the House), in respect to which the Senate had concurred in adoption of the emergency preamble, was put upon its final passage.

Bill enacted (state loan), yea and nay No. 28. On the question on passing the bill to be enacted, the sense of the House was taken by yeas and nays (this being a "loan" bill as defined by Section 3 of Article LXII of the Amendments to the Constitution); and on the roll call 157 members voted in the affirmative and 0 in the negative.

Therefore the bill was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
