Pledge of allegiance.

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Message from the Governor.

Groveland, election. A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to the 2015 annual town election in the town of Groveland (House, No. 3552), was filed in the office of the Clerk on Thursday, May 21.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Election Laws. Sent to the Senate for concurrence.

Motion to Suspend Rule 24(2).

Supreme Judicial Court opinions, money bills Mr. DeLeo of Winthrop then moved that Rule 24(2) be suspended so that he might offer, from the floor, an Order requiring the opinions of the Supreme Judicial Court on certain questions of law pertaining to the origin of a "money bill" in relation to the General Appropriations Bill for fiscal year 2016.

The motion to suspend Rule 24(2) prevailed; and the order (House, No. 3551) was adopted.
