The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 1964) was referred, in concurrence, to the committee on the Judiciary.

Under Rule 42, the report was considered forthwith; and it was accepted. Sent to the Senate for concurrence.

By Mr. Nangle of Lowell, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:

Establishing a sick leave bank for Raoul Santos, an employee of Military Division (House, No. 3625); and

Establishing a sick leave bank for Craig Lindberg, an employee of the Department of Children and Families (House, No. 3642);

Under suspension of Rule 7A, in each instance, on motion of the same member, the bills severally were read a second time forthwith; and they were ordered to a third reading.

Eastham, land. ments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 3401), recommending, a Bill relative to the conveyance of easements in the town of Eastham (House, No. 3651), was accepted. The report then was sent to the Senate for concurrence.

General Appropriation Bill The report, in part, of the committee of conference on the disagreeing votes of the two branches with reference to the Senate amendment (see Senate document numbered 1930) of the House Bill making appropriations for the fiscal year 2016 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (House, No. 3650), was considered.

Conference committee report accepted, yea and nay No. 56. After debate on the question on acceptance of the report, the sense of the House was taken by yeas and nays, at the request of Mr. Dempsey of Haverhill; and on the roll call 153 members voted in the affirmative and 1 in the negative.

General Appropriation Bill The engrossed Bill making appropriations for the fiscal year 2016 for the maintenance of the departments, boards, commissions, institutions and certain activities of the Commonwealth, for interest, sinking fund and serial bond requirements and for certain permanent improvements (see House, No. 3650), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Bill enacted.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill relative to the conveyance of easements in the town of Eastham (see House, No. 3651), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.
