The House Bill relative to amending the composition of the Nantucket Historic District Commission (House, No. 3618) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Madden of Nantucket moved to amend it by striking out sections 2 and 3 and inserting in place thereof the following three sections:

"SECTION 2. Notwithstanding section 1, an incumbent member of the Historic District Commission previously appointed or elected pursuant to section 3 of chapter 395 of the acts of 1970 shall continue to serve in that capacity until the expiration of the incumbent's term or until the incumbent sooner vacates the office. After the expiration of the term of an incumbent member, or a sooner vacating of the office, a new member shall be elected pursuant to section 1.

SECTION 3. Section 3 of chapter 338 of the acts of 2014 is hereby repealed.

SECTION 4. This act shall take effect upon its passage.".

The amendments were adopted; and the bill (House, No. 3618, amended) was passed to be engrossed. Sent to the Senate for concurrence.
