Petitions.

Mr. Nangle of Lowell, for said committee, then reported that the matters be scheduled for consideration by the House.

By Ms. Peisch of Wellesley, for the committee on Education, on a petition, a Bill relative to providing feedback on educator certification tests (House, No. 395). Read; and referred, under Rule 33, to the committee on Ways and Means.

Engrossed Bill.

The engrossed Bill amending the charter of the town of Provincetown to change the residency requirement for certain officials (see House, No. 3585) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Orders of the Day.

The engrossed Bill relative to the charter of the city of Newton (see House, No. 3563), which had been returned to the House by His Excellency the Governor with recommendation of amendment (for message, see House, No. 3752), was considered.

The committee on Bills in the Third Reading reported recommending that the amendment recommended by the Governor be considered in the form contained in the message from the Governor, as approved by said committee; and the report was accepted. The amendment then was adopted. Sent to the Senate for its action.

The House Bill designating a certain bridge in the town of Hudson as the Captain Seth R. Michaud Memorial Bridge (House, No. 3592), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.
