Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Pledge of allegiance.

At the request of the Chair (Mr. Donato), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Message from the Governor — Veto.

Boston, retired police. A message from His Excellency the Governor returning with his objections thereto in writing the engrossed Bill authorizing the appointment of retired police officers as special police officers in the city of Boston [see House, No. 2339] (for message, see House, No. 3759), was filed in the office of the Clerk on Friday, September 11.

The message was read; and, under House Rule 12, it was placed in the Orders of the Day for the next sitting.

Guests of the House.

Upton Senior Center. At the beginning of the session, the Chair (Mr. Donato of Medford), declared a brief recess and introduced, seated in the House Chamber, guests from the Upton Senior Center. At the invitation of the Chair, the guests participated in the pledge of allegiance to the flag. They were the guests of Mr. Muradian of Grafton.

Petition.

Bolton, liquor licenses. Representative Hogan of Stow and Senator Flanagan presented a joint petition (accompanied by bill, House, No. 3761) of Kate Hogan and Jennifer L. Flanagan (by vote of the town) that the town of Bolton be authorized to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises; and the same was referred to the committee on Consumer Protection and Professional Licensure. Sent to the Senate for concurrence.

House bills

Holyoke, size of city council. Reducing the size of the City Council of the city of Holyoke (House, No. 3329), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 4, in line 17, striking out the figures "60" and inserting in place thereof the figures "35";

Holyoke, term of mayor. Establishing a 4-year term for the office of Mayor of the city of Holyoke (House, No. 3558), came from the Senate passed to be engrossed, in concurrence, with an amendment in section 4, in line 17, striking out the figures "60" and inserting in place thereof the figures "35"; and

Holyoke, appointed treasurer. Establishing an appointed treasurer for the city of Holyoke (House, No. 3734), came from the Senate passed to be engrossed, in concur-

rence, with an amendment in section 8, in line 51, striking out the figures "60" and inserting in place thereof the figures "35";

The amendments severally were referred, under Rule 35, to the committee on Bills in the Third Reading.

DiDomenico, Ruth B. Balser and other members of the General Court for legislation relative to the enhanced management of early childhood caries among MassHealth patients;

And recommending that the same severally be referred to the committee on Health Care Financing.

Severally accepted by the Senate, were considered forthwith, under Rule 42; and they were accepted, in concurrence.

Gentile and Chris Walsh for legislation to establish a sick leave bank for Deborah Clay, an employee of the Trial Court. Under suspension of the rules, on motion of Mr. McMurtry of Dedham, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Judiciary. Sent to the Senate for concurrence.
