#### Monday, November 2, 2015.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

#### Resolutions.

Resolutions (filed with the Clerk by Mr. Tucker of Salem) commending Dolores Jordan for her dedicated service to the city of Salem, were referred, under Rule 85, to the committee on Rules.

#### Reports of Committees.

By Mr. Galvin of Canton, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the petition of Alan Silvia and Michael J. Rodrigues relative to establishing a sick leave bank for Lucia R. Dias, an employee of the Bristol County House of Correction. Under suspension of the rules, on motion of Mr. Smizik of Brookline, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Sent to the Senate for concurrence.

By Mr. Nangle of Lowell, for the committee on Steering, Policy and Scheduling, that the House Bill establishing a year-round market rate rental housing trust in the town of Provincetown (House, No. 3742) [Local Approval Received], be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Kafka of Stoughton, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. O'Day of West Boylston, for the committee on Municipalities and Regional Government, on a petition, a Bill authorizing the town of North Reading to transfer and convey certain property (House, No. 3819) [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Nangle of Lowell, for said committee, then reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Mr. Kafka of Stoughton, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Kocot of Northampton, for the committee on State Administration and Regulatory Oversight, on a petition, a Bill relative to the establishment of a historical preservation fund (House, No. 2830). Read; and referred, under Rule 33, to the committee on Ways and Means.

By Mr. Nangle of Lowell, for the committee on Steering, Policy and Scheduling, that the House Bill relative to the removal of veterans, police and fire, commemorative flag holders (House, No. 3173), be scheduled for consideration by the House; and under Rule 7A, it was placed in the Orders of the Day for the next sitting for a second reading.
