## Message from the Governor.

A message from His Excellency the Governor (under the provisions of Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to a town meeting held in the town of Rochester (House, No. 3918), was filed in the office of the Clerk on Thursday, December 17.

The message was read; and it was referred under Rule 30, with the accompanying draft of a bill, to the committee on Election Laws. Sent to the Senate for concurrence.
