Representative Peisch of Wellesley and Senator Jehlen presented a joint petition (subject to Joint Rule 12) of Alice Hanlon Peisch relative to reviving and continuing the special commission established (under Chapter 449 of the Acts of 2014) to make an investigation and study of

the development and implementation process of a six year career plan to be coordinated by licensed school guidance counselors for all students in grades 6 to 12; and the same was referred, under Rule 24, to the committee on Rules.

Subsequently, under suspension of the rules, on motion of the same member, the bill (having been reported by the committee on Bills in the Third Reading to be correctly drawn) was read a third time; and it was passed to be engrossed, in concurrence.

A Bill further regulating the designation of certain state entities (Senate, No. 2083) (on Senate bill No. 2082), passed to be engrossed by the Senate, was read; and it was referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

The House Bill authorizing the city of Fitchburg to use ImageCast precinct tabulators at a special state primary (House, No. 3864) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it by adding the following section:

“SECTION 2. This act shall take effect upon its passage.”.

The amendment was adopted; and the bill (House, No. 3864, amended) was passed to be engrossed. Sent to the Senate for concurrence.
