Today we note the anniversary of the first patent secured by the inventor Lewis Howard Latimer. Mr. Latimer was born in 1848 and was raised in Chelsea, the son of abolitionists who themselves escaped from slavery in Virginia. After serving in the U.S. Navy, Lewis Latimer returned to Boston and found work with a firm that assisted inventors in procuring patents. On his own, Latimer studied the detailed drawings required for patent applications and he bought the necessary drafting tools and taught himself the skills of the trade. He eventually became an inventor himself, working in the growing field of electricity. Latimer's work distinguished him enough to get the attention of Thomas Edison who hired him to work on improving Edison's light bulb. Latimer did just that by inventing a carbon filament that greatly extended the life of the light bulb.

We give thanks to our God of Creativity and Inspiration for such a native son of Massachusetts.

May God continue to bless our Commonwealth.
