Monday, March 6, 2017.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by Father Rick Walsh of the Paulist Center of Boston, Chaplain of the House, as follows:

Loving God we pray for the membership of our House and for the many people who work here. We pray especially today for the Sergeant-at-Arms and his court officers. May they continue to provide courteous assistance to all who enter this Chamber

We remember that yesterday was the 247th anniversary of the Boston Massacre. The killing of five civilians by British soldiers was used by Sam Adams and the Sons of Liberty as a rallying cry against the tyrannical rule and practices of the crown against the colonists in Massachusetts and beyond.

In time, the soldiers were successfully defended in court by a young John Adams, a cousin of Sam Adams.

In truth there was a growing hostility between laborers like Crispus Attucks who vied for employment with British soldiers on leave in Boston. There was a growing air of hostility and frequent fights between these two groups and the animosity came to a head on March 5th, when a large crowd of colonists surrounded one soldier on duty near the Customs House. Soon other soldiers came to his rescue. In the chaos of shouting and pushing the soldiers heard the word "fire" and they discharged their weapons into the mob.

The killing proved to be an alarm for many colonists and helped move some toward favoring independence. We honor the memory of Crispus Attucks, Samuel Gray, James Caldwell, Samuel Maverick and Patrick Carr, a recent immigrant from Ireland, who are buried in the Old Granary Burial site on Tremont Street, close to where they died.

May God continue to bless our Commonwealth.
