Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Moran of Boston in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by Father Rick Walsh of the Paulist Center of Boston, Chaplain of the House, as follows:

God of Courage, God of Hospitality, we pray today for our legisla- Prayer. tors and for all who work within this edifice. We pray that all who make the journey to visit their elected officials may be greeted warmly and respectfully. We pray too that the hard work of our legislators be respected by those they serve.

We pray in this vein because we remember that today is the anniversary of the 1621 visitation by the native American Samoset to the colonists at Plimouth Colony. Samoset greatly surprised the Pilgrims with his ability to converse in English, a skill he learned from his past interactions with a company of Englishmen who had been fishing for cod off the coast of what is now Maine.

Samoset was a sagamore or chieftain of the native Abenaki tribe. He explained to the settlers that the land they were dwelling upon was called Patuxet and that a plague had wiped out all but one native named Squanto whom he brought to the colony days later. The courage of Samoset and the hospitality of the native persons contributed greatly to the colony's survival.

We pray today for those residents of Massachusetts whose heritage and culture include membership in the Wompanoag tribe.

May God continue to bless our Commonwealth.

third reading. Subsequently under suspension of the rules, on motion of Mr. Kafka of Stoughton, the bill (having been reported by the committee on Bills

in the Third Reading to be correctly drawn) was read a third time. Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in line 6 by striking out the words "department paid" and inserting in place thereof the words "extended illness".

The amendment was adopted; and the bill (House, No. 2776, amended) was passed to be engrossed. Sent to the Senate for concurrence.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the trial court, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was adopted; and the bill (House, No. 905, amended) was passed to be engrossed. Sent to the Senate for concurrence.
