Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Moran of Boston in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Communication.

Plymouth District Attorney.—wiretaps. A communication from the District Attorney of Plymouth County (see Section 99 of Chapter 272 of the General Laws) submitting a report relative to wiretaps for the calendar year 2016, was placed on file.

Petitions.

Petitions severally were presented and referred as follows:

Salem.—liquor license. By Mr. Tucker of Salem, a petition (accompanied by bill, House, No. 2793) of Paul Tucker and Joan B. Lovely (with the approval of the mayor and city council) that the city of Salem be authorized to grant one additional license for the sale of wine and malt beverages not to be drunk on the premises. Shrewsbury.—town manager residency. By Representative Kane of Shrewsbury and Senator Moore, a joint petition (accompanied by bill, House, No. 2795) of Hannah Kane and Michael O. Moore (by vote of the town) relative to residency requirements of the town manager of the town of Shrewsbury. To the committee on Public Service.

Nantucket.—real estate transfer fees. By Representative Fernandes of Falmouth and Senator Cyr, a joint petition (accompanied by bill, House, No. 2794) of Dylan Fernandes and Julian Cyr (by vote of the town) that the town of Nantucket be authorized to impose real estate transfer fees for certain housing. Health benefits.—moratorium. By Mr. Jones of North Reading, a petition (subject to Joint Rule 12) of Bradley H. Jones, Jr., for the imposition of a moratorium on the enactment of new mandated health benefits.

By the same member, a petition (subject to Joint Rule 12) of Bradley H. Jones, Jr., relative to requiring that the health care cost growth benchmark be equal to the growth rate of potential gross state product.

By Mr. Wagner of Chicopee, a petition (subject to Joint Rule 12) of Joseph F. Wagner and Eric P. Lesser for legislation to establish a sick leave bank for Kevin Blake, an employee of the Massachusetts Department of Transportation.

Papers from the Senate.

A petition (accompanied by bill, Senate, No. 2040) of Michael D. Brady, Gerard Cassidy, Claire D. Cronin and Michelle M. DuBois (with approval of the mayor and city council) for legislation relative to the appointment of special police officers in the city of Brockton, was referred, in concurrence, to the committee on Public Service.

A petition of Sal N. DiDomenico and Daniel J. Ryan for legislation to establish a sick leave bank for Ramona Foster, an employee of the Department of Elementary and Secondary Education, came from the Senate referred, under suspension of Joint Rule 12, to the committee on Public Service.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2042) was referred, in concurrence, to the committee on Public Service.

Report of the Committee on State Administration and Regulatory Oversight on Executive Reorganization Plan No. 1 of 2017.

In accordance with a provision of Joint Rule 23A, the committee on State Administration and Regulatory Oversight, to whom was referred Reorganization Plan No. 1 of 2017 (submitted by the Governor under the provisions of Article LXXXVII of the Amendments to the Constitution) to reorganize the Department of Public Safety (see House, No. 68) [for report, see Senate document numbered 2037],—reported, in accordance with a provision of Joint Rule 23A, recommending that said Reorganization Plan Number 1 “ought to be approved”.

Placed in the Orders of the Day for the next sitting, the question being, “Shall this reorganization plan be approved?”.
