

JOURNAL OF THE HOUSE.

Thursday, April 13, 2017.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by Father Rick Walsh of the Paulist Center of Boston, Chaplain of the House, as follows:

Prayer. God of Creation, we give You thanks today for the budding of trees and the return of migrating birds. We feel blessed to live in a small state with sandy beaches and lush forests.

We give thanks for our legislators who we pray for their work to help keep the Massachusetts air and water clean and pure.

Today we remember that in 1933, the first members of the Civilian Conservation Corps arrived at Fort Devens for registration and training. These men eventually went to work throughout the state to create trails, roads, bridges, picnic pavilions thus helping to create our state parks. Faced with high unemployment, President Franklin Delano Roosevelt created the CCC to put young, able-bodied men to work throughout the country.

In Massachusetts, over a nine year period over 100,000 men were put to work planting over 12,000,000 trees on de-forested land and abandoned pastures. They also created ponds and lakes by constructing dams in some locations. They were paid \$30 per month with the requirement to send \$25 back to their families and to spend \$5 to help the local rural economy. Their legacy is found today whenever one goes for a hike on Mounts Wachusett or Greylock or enjoys the view from the Eliot Observatory Tower in the nearby Blue Hills Reservation.

May God continue to bless our Commonwealth.
