Today we remember the town of Lexington as yesterday was the anniversary of the battle there in 1775, the first in the American Colonies' War of Independence. Of the 77 militia who engaged the British regulars in battle, 8 died and 10 others were wounded. With its Battle Green, historic taverns, homes and burial grounds, Lexington remains one of most significant destinations for tourists who come to Massachusetts.

The man atop the fieldstone base of the famous Minuteman statue is supposed to depict Captain John Parker, leader of the Lexington militia in 1775, although no images of him exist. Medford resident Arthur Mather, among others, served as a model for the sculptor.
