### *Message from the Governor.*

A message from His Excellency the Governor (under Section 8 of Article LXXXIX of the Amendments to the Constitution) recommending legislation relative to authorizing the town of Tisbury to pay a certain unpaid bill (House, No. 3710), was filed in the office of the Clerk on Monday, May 15. ### *Statement of Representative Walsh of Framingham.*

Petitions.

Petitions severally were presented and referred as follows:

Lee,—fuels tax. By Representative Pignatelli of Lenox and Senator Hinds, a joint petition (accompanied by bill, House, No. 3707) of William Smitty Pignatelli and Adam G. Hinds (by vote of the town) that the town of Lee be authorized to establish a local excise on the sale of gasoline and diesel fuels. To the committee on Revenue. State flag,—half-staff. By Mr. Garballey of Arlington, a petition (subject to Joint Rule 12) of Sean Garballey relative to flying the flag of the Commonwealth at half-staff annually to honor certain veterans and POWs/MIAs.

Justin Rizzo,—sick leave. By Mr. Hunt of Boston, a petition (subject to Joint Rule 12) of Daniel J. Hunt for legislation to establish a sick leave bank for Justin Michael Rizzo, an employee of the Department of Labor Standards.

Alison Dejordy,—sick leave. By Representative O'Day of West Boylston and Senator Chandler, a joint petition (subject to Joint Rule 12) of James J. O'Day and Harriette L. Chandler for legislation to establish a sick leave bank for Alison Dejordy, an employee of the Department of Children and Families.

Richard Capone,—sick leave. By Mr. Wong of Saugus, a petition (subject to Joint Rule 12) of Donald H. Wong and Thomas M. McGee for legislation to establish a sick leave bank for Richard Capone, an employee of the Department of Transportation. Severally, under Rule 24, to the committee on Rules.

Bourne Recreation Authority,—bonds. A petition (subject to Joint Rules 9 and 7B) of David T. Vieira, Randy Hunt and Viriato M. deMacedo relative to bonds issued by the Bourne Recreation Authority (having been deposited in the office of the Clerk previous to five o'clock in the afternoon on Friday, January 20, 2017) was transmitted to the State Secretary under Chapter 3 of the General Laws.

Reports of Committees.

By Ms. Cronin of Easton, for the committee on the Judiciary, asking to be discharged from further consideration:

Of so much of the recommendations of the Commission on Uniform State Laws (House, No. 42) as relates to making uniform the law regarding trade secrets (House, No. 43); and

Of the petition (accompanied by bill, House, No. 854) of Bradley H. Jones, Jr., and others relative to the regulation of trade by the establishment of a uniform trade secrets act;

And recommending that the same severally be referred to the committee on Labor and Workforce Development.

By Ms. Hogan of Stow, for the committee on Public Health, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 1198) of Paul McMurtry relative to quarterly billing by health maintenance organizations for certain health services,—and recommending that the same be referred to the committee on Financial Services.

Under Rule 42, the reports severally were considered forthwith; and they were accepted. Severally sent to the Senate for concurrence.

By Ms. Cariddi of North Adams, for the committee on Environment, Natural Resources and Agriculture, on House, No. 3658, a Bill designating a certain park in the town of Hingham as the Eugene F. Credon Memorial Park (House, No. 3708). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Murphy of Weymouth, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Ms. Barber of Somerville, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Murphy of Weymouth, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:

By Ms. Peisch of Wellesley, for the committee on Education, on a petition, a Resolve providing for an investigation and study by a special commission relative to child suicide (House, No. 263). Read; and

referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.
