Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mrs. Haddad of Somerset in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

By Mr. Parisella of Beverly, for the committee on Public Service, on a petition, a Bill establishing a sick leave bank for Mary Goddard, an employee of the Department of Correction (House, No. 3868).

By the same member, for the same committee, on a petition, a Bill establishing a sick leave bank for Lornece Tull, an employee of the department of corrections [sic] (House, No. 3877).

Marshfield,—
Route 3 designation.

By Mr. Straus of Mattapoisett, for the committee on Transportation, on a petition, a Bill designating Marshfield the home of Senator Daniel Webster and Governor Edward Winslow (House, No. 1806).

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

The engrossed Bill establishing a sick leave bank for Renee Salisbury, an employee of the Department of Transitional Assistance (see Senate, No. 2101, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Bill enacted.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill establishing a sick leave bank for Michelle Dancy, an employee of the Department of Mental Health (see Senate, No. 2116), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Bill enacted.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

In respect to each of which the Senate had concurred in adoption of the emergency preamble, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in section 1, in line 6, by inserting after the word "purposes" the words "and upon retirement, he shall receive a superannuation retirement allowance equal to that which he would have been entitled had he retired on that date".

The amendment was adopted; and the bill (House, No. 3834, amended) was passed to be engrossed. Sent to the Senate for concurrence.
