Reports of Committees.

By Mr. Murphy of Weymouth, for the committee on Steering, Policy and Scheduling, that the House Bill authorizing the Division of Capital Asset Management and Maintenance to grant easements to the town of Lanesborough for the reconstruction of the Narragansett Avenue Bridge over Lake Pontoosuc (House, No. 3767), be scheduled for consideration by the House, with the amendment previously recommended by the committee on Ways and Means, pending. Under suspension of Rule 7A, on motion of Mr. Smizik of Brook-

line, the bill was read a second time forthwith.

The amendment recommended by the committee on Ways and Means,— that the bill be amended by substitution of a bill with the same title (House, No. 3920),- then was adopted; and the substituted bill was ordered to a third reading.

By Mr. Murphy of Weymouth, for the committee on Steering, Policy and Scheduling, that the following House bills be scheduled for consideration by the House:

Relative to certain affordable housing in the East Boston section of the city of Boston (House, No. 2243) [Local Approval Received]; and Relative to certain affordable housing in the South End section of

the city of Boston (House, No. 3540) [Local Approval Received]; Under suspension of Rule 7A, in each instance, on motion of Mr. Smizik of Brookline, the bills severally were read a second time forthwith; and they were ordered to a third reading.

By Mr. Honan of Boston, for the committee on Housing, on House, Nos. 675 and 3653, a Bill financing the production and preservation of housing for low and moderate income residents (House, No. 3925). Read; and referred, under Rule 17G, to the committee on Bonding, Capital Expenditures and State Assets.

Engrossed Bill.

The engrossed Bill authorizing retired police officers serving as Bill special police officers in the town of Canton to serve until the age enacted. of 70 (see House, No. 3885) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Orders of the Day.

The Senate Bill authorizing the town of Palmer to issue an additional license for the sale of all alcoholic beverages not to be drunk on the premises (Senate, No. 2051) (its title having been changed by the bill. Third reading bill. to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

The House Bill authorizing the city of Revere to pay a certain sum Id. of money (House, No. 3876) (its title having been changed by the committee of Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time; and it was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill further regulating the appointment of trustees of the public library of the city of Boston (House, No. 3862), reported by the Boston,-library trustees committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it by striking out section 2 and inserting in

place thereof the following two sections: "SECTION 2. Said section 3 of said chapter 114, as appearing in said section 1 of said chapter 157 of the acts of 1994, is hereby further amended by striking out, in line 5, the words 'one member' and insert-ing in place thereof the following words:— up to 7 members. SECTION 3. This act shall take effect upon its passage.".

The amendment was adopted; and the bill (House, No. 3862, amended) was passed to be engrossed. Sent to the Senate for concurrence.
