Resolutions.

Resolutions (filed with the Clerk by Mr. McKenna of Webster) congratulating the St. Joseph School on the occasion of its one hundred twenty-fifth anniversary, were referred under Rule 85, to the committee on Rules.

A Bill exempting the position of police captain in the town of Hull from the civil service law (Senate, No. 2086) (on a petition), passed to be engrossed by the

A report of the committee on Consumer Protection and Professional Licensure, asking to be discharged from further consideration of the petition (accompanied by bill, Senate, No. 142) of Michael O. Moore and Colleen M. Garry for legislation relative to graduate education for certain professionals, and recommending the same be referred to the committee on Public Health,— accepted by the Senate, was considered forthwith, under Rule 42; and it was accepted, in concurrence.

Under suspension of Rule 7A, in each instance, on motion of Mr. Kaufman of Lexington, the bills severally were read a second time forthwith; and they were ordered to a third reading.

Orders of the Day.

The Senate Bill establishing a town manager in the town of West Newbury (Senate, No. 2161), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

The House Bill authorizing the town of Lenox to convey a conservation restriction on certain parcels of land (House, No. 3833), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Danvers moved to amend it by striking out section 2 and inserting in place thereof the following section:

“SECTION 2. The parcels of land to be restricted pursuant to section 1 are identified as follows: (i) all of the land in the town of Lenox recorded in certain orders of taking and deeds in the Berkshire middle district registry of deeds in: (1) book 531, page 545, except the property described in book 588, page 8; (2) book 848, page 384; (3) book 558, page 245; (4) book 636, page 591; (5) book 644, page 338 and book 657, page 188; and (6) book 5880, page 148; and (ii) all of the land recorded in a deed in the Berkshire middle district registry of deeds in book 1201, page 913.”.

The amendment was adopted; and the bill (House, No. 3833, amended) was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill increasing the exemption for residential property in the town of Provincetown (House, No. 3860), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it by adding the following section:

“SECTION 3. This act shall take effect upon its passage.”.

The amendment was adopted; and the bill (House, No. 3860, amended) was passed to be engrossed. Sent to the Senate for concurrence.

The House Bill establishing a sick leave bank for Laura Sypien, an employee of the Worcester Recovery Center and Hospital (House, No. 3923), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved that it be amended by substitution of a Bill establishing a sick leave bank for Laura Sypien, an employee of the Department of Mental Health (House, No. 3949), which was read.

The amendment was adopted; and the substituted bill was passed to be engrossed. Sent to the Senate for concurrence.
