As a member of a local militia since 1759, Glover was a recognized leader early on

The Marblehead militia or Glover's regiment (as it was known) was composed almost entirely of fishermen and was used by General George Washington as a naval regiment. Washington enlisted of Glover's experi-ence as a seaman to raid British supply vessels. His ship the Hannah was the first to be used for military service and as such is considered the first vessel of the United States Navy. Later in the war, it was Glover's regiment that helped enable Washington and his troops to cross the Delaware River on December 26, 1776

Recess.

At twenty-seven minutes before twelve o'clock noon, on motion of Mr. Barrows of Mansfield (Mr. Donato of Medford being in the Chair), the House recessed subject to the call of the Chair; and at twenty-nine minutes before six o'clock P.M. the House was called to order with Mr. Donato in the Chair.

Reports of Committees.

At twenty minutes before six o'clock P.M., on motion of Mr. D'Emilia Recess. of Bridgewater (Mr. Donato of Medford being in the Chair), the House recessed subject to the call of the Chair; and at five minutes before six o'clock P.M. the House was called to order with Mr. Donato in the Chair.

Emergency Measure.

The engrossed Bill making appropriations for the fiscal year 2017 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4008), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 2 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed enacted, to be enacted; and it was signed by the acting Speaker and sent to the Senate.
